## Call for Expressions of Interest

**Consultancy Service in the framework of the project “GET UP AND GOALS! Global education time: an international network of learning and active schools for SDGs”**

### 1. Background Information

*Comitato Internazionale per lo Sviluppo dei Popoli* – CISP (International Committee for the Development of Peoples) is a Non Governmental Organization (NGO) established in 1983, which has its headquarters in Rome, Italy. The principles and aims of the organization are summarized in the Declaration of Intent and Code of Conduct for Cooperation Programmes, available on the website of CISP [www.sviluppodeipopoli.org](http://www.sviluppodeipopoli.org).

The Declaration of Intent is titled “Rights, Change, Sustainability” and is inspired by the 2030 Agenda and its 17 Sustainable Development Goals.

In co-operation with national and international, public and private partners, CISP has implemented and implements projects in the areas of humanitarian assistance, rehabilitation and development in more than 30 countries in Africa, Latin America and Caribbean Region, Middle East, Mediterranean Region, Asia and Eastern Europe.

In the countries of the European Union CISP carries on awareness raising activities, promotes international solidarity and supports initiatives aiming at fighting against social exclusion in support of vulnerable groups, including migrants, refugees and asylum seekers.

On October 2, 2017 CISP has signed a Grant Contract with the European Commission (EC) for the implementation of a three years project (hereinafter “the project”) named **GET UP AND GOALS! Global education time: an international network of learning and active schools for SDGs**. The project, framed under the EC DEAR (Development Education and Awareness Raising) initiative, is implemented in partnership with other nonprofit entities in the following EU countries: Italy, Republic of Ireland, Czech Republic, Bulgaria, Hungary, Portugal, The Netherlands, Poland, Austria, Romania, Spain and United Kingdom.

The general objective of the project is “To contribute to structurally link formal education to Global Citizenship Education (GCE) and awareness on SDGs”, while the expected outcomes are the following:

- European teachers and other stakeholders (schools managers, institutions in charge for education) are aware of GCE and of the SDGs;
- Teachers participating in training have the competencies and the adequate materials to embed it in their teaching of SDGs;
- Students have improved their commitment on project issues through the participation in public awareness actions on SDGs; and
- Increased the coherence of quality assessment of GCE learning outcomes, in formal education, at a European level.

One important component of the project consists in the development of a textbook of world geo-history, to be utilised in the European secondary schools of the 12 countries involved in the project, subsequently to its

testing and further adaptation. A team of experts has been appointed to develop the textbook. The scope of the consultancy, as described at point 2, is to collaborate to the final version of this textbook in order to make it suitable for schools.

## **2. Nature and scope of the Consultancy Services**

CISP is seeking for one or more qualified consultants who would be in charge for the following tasks. The candidate can apply also for only one task.

- 1) **Provide**, in close coordination with the team of experts, the textbook with educational and didactical tools. The consultant is expected to design and set up: geographic maps, mental maps, other iconic supports, photographs. The scope is to reinforce the students' skills and knowledge on the following topics: global migration, climate change, gender inequality, international inequalities. The final product will be delivered by July 2019; **Inspired** by the textbook contents, develop 4 complete English Teaching and learning units (TLUs), in a Global Citizenship Education perspective for teachers and students of the secondary schools of the 12 partner countries, on the following themes: global migration, climate change, gender inequality, international inequalities. The final product will be delivered by September 2019; **Support** CISP in the monitoring, further revision and correction of the geo history textbook during and at the end of its testing in the schools in the school year 2019-20
- 2) Provide, in close coordination with the team of experts, the textbook with charts, infographics, historical maps, layouts based on an appropriate iconographic research, for a world geo-history textbook

## **3. How to apply**

Interested applicants are invited to submit to CISP, only through e-mail forwarded at the address [cisp@cisp-ngo.org](mailto:cisp@cisp-ngo.org) writing in the subject "**CISP Consultancy Textbook**" no later than July 25 at 05:00 pm Italian time their CV and any attachment considered appropriate with evidenced **academic qualifications, professional assignments undertaken** and any other information relevant to the subject of the consultancy as indicated at paragraph 2. Candidates are also encouraged to submit digital copies of at least one recent publication relevant to the subject of the consultancy. Candidates are also requested to demonstrate an **outstanding knowledge of the English language**.

## **4. Further procedures to be applied**

CISP will establish a selection committee to assess the appropriateness of the candidates in accordance to the criteria listed at paragraph 3, namely: academic qualifications, professional assignments undertaken, outstanding knowledge of the English language. Only candidates meeting the required criteria, in accordance to unquestionable evaluations done by the selection committee, will be contacted. Should the committee consider it necessary, candidates will be asked to provide additional information and/or documentation.

Subsequently "ad hoc" separate meetings with the pre-selected candidates will be arranged. In the case of candidates non residing in Italy meetings could also be arranged by skype. During these meetings the nature of the assignment will be further explained and candidates will be requested to submit a financial offer, inclusive of any due fiscal cost.

Finally, CISP will select the consultant/s and propose her/him to sign a contract in accordance with the labour laws of Italy.
